- B. Summary of meeting with Joe Millon, Executive Director of NetCorps. Deb Jones and I had a very productive meeting with Joe Millon of NetCorps on Monday. One of the outcomes that I hope can be reached is that the IT functions can be divided among a few people rather than relying on one person to do all the web maintenance, the membership database, and the newsletter and board site.
